- (3) Children of those belonging to the All India Services/Central Services liable to inter-state transfer, migrants from out of State who are temporarily put up in this State/employees of all India level business/commercial and industrial establishments and Anglo-Indians shall get preference in admissions.
- (4) Admission to pre-primary stage, should be done in the month of April every year.

- (5) The NO OBJECTION CERTIFICATE along with the conditions subject to which the same has been issued should be exhibited in a conspicuous place in the Chambers of the Principal/Head Master/Head Mistress, for the benefit of general public.
- (6) For starting the pre-primary school (Nursery/LKG /UKG etc.,) the management shall obtain prior permission by registering the same in accordance with the Karnataka Educational Institutions (Classification and Registration) Rules, 1997.
- (7) A School cannot be started merely on the ground that this NOC has been issued, without first obtaining affiliation/recognition from CBSE/CISCE. In case the said educational institution intends to start a school before obtaining such affiliation/recognition from CBSE/CISCE, it shall seek permission of the competent authority to start a state syllabus school and recognition and registration thereof, in accordance with the rules made by the Government of Karnataka under the Karnataka Education Act, 1983
- (8) Any other conditions that may be imposed in future.
- (9) Government of Karnataka may take action to withdraw this No Objection Certificate in case any of the conditions is violated.
